WHEREAS, the aforementioned request was approved as detailed below:

WHEREAS, the Philippine Carabao Center (PCC), an attached agency of the Department of Agriculture, was created by virtue of Republic Act No. 7307;

WHEREAS, PCC is mandated to conserve, propagate and promote the Carabao as a source of draft animal power, milk, meat and hide to benefit rural farming families thereby improving their general well being, through Carabao genetic improvement, technology development and dissemination;

WHEREAS, in order to attain the above objectives, the procurement of supplies, services and other materials are needed to sustain operations;

WHEREAS, in accordance with Sections 3 and 4, Article I of Republic Act No. 9184 and Sections 4.1, Rule I of its Implementing Rules and Regulations (IRR), public bidding is required in the procurement of infrastructure projects, goods and consulting services;

WHEREAS, funds for the purpose is available;

WHEREAS, the Invitation to Bid (ITB) for this requirement was posted in the Philippine Carabao Center official website and published in the Philippine Carabao Center on November 27, 2013 and simultaneously posted in the following:

- a. PhilGEPS Official Website
- b. Conspicuous places in the premises of the procuring entity

WHEREAS, in response to the Invitation to Bid, P&J Agricultural Trading, Inc. secured the bidding documents;

WHEREAS, the Pre-bid Conference was held on December 5, 2013 (10:00 a.m.) at the PCC Shahani Room, National Headquarters and Gene Pool, Science City of Muñoz, Nueva Ecija;

WHEREAS, the Opening of Bids was held on December 17, 2013 (10:00 a.m.) at the PCC Shahani Room, National Headquarters and Gene Pool, Science City of Muñoz, Nueva Ecija participated in by a sole bidder (P&J Agricultural Trading, Inc.);

WHEREAS, RA 9184 provides that opening of eligibility documents shall be based on a non-discretionary pass/fail criteria;

WHEREAS, the sole bidder who submitted, the complete set of eligibility and technical components complied with the requirements and was considered for the opening of the financial proposal;

WHEREAS, after review of the findings, the BAC resolved to consider the recommendation of the PCC-BAC's TWG;





Bids received in excess of the ABC shall be automatically rejected at bid opening.

The PHILIPPINE CARABAO CENTER (PCC) now invites bids for the **SUPPLY, DELIVERY AND INSTALLATION OF TWO (2) UNITS SIMPLE TYPE QUICK LNG FREEZER**. Delivery of the Goods is required within 90-120 calendar days. Bidders should have completed, within the last (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
