WHEREAS, the Philippine Carabao Center (PCC), an attached agency of the Department of Agriculture, was created by virtue of Republic Act No. 7307;

WHEREAS, PCC is mandated to conserve, propagate and promote the Carabao as a source of milk, meat, draft power and hide to benefit the rural farmers;

WHEREAS, in order to attain the above objectives, the procurement of supplies, services and other materials are needed to sustain operations;

WHEREAS, in accordance with Sections 3 and 4, Article I of Republic Act No. 9184 and Sections 4.1, Rule I of its Implementing Rules and Regulations (IRR), public bidding is required in the procurement of infrastructure projects, goods and consulting services;

WHEREAS, the public bidding for the said project resulted to two (2) failed biddings as per BAC Resolution Nos. 2019-379 and 2019-539 and the BAC recommended the adoption of Negotiated Procurement (Section 53.1-Two Failed Biddings) pursuant to the Revised IRR of RA 9184;

WHEREAS, funds for the purpose is available;

WHEREAS, the Invitation to Bid (ITB) for the negotiated procurement was posted in the Philippine Carabao Center official website on 24 November 2019 and simultaneously posted in the following:

- b. Conspicuous places in the premises of the procuring entity

WHEREAS, in response to the Invitation to Bid, JHAK CONSTRUCTION secured the documents relative to the project;

WHEREAS, the Opening of Sealed Quotation/Proposal was held on 2 December 2019 (10am) at the Conference Room No. 2, 3rd Floor, LIB Complex Building, PHILIPPINE CARABAO CENTER, National Headquarters and Gene Pool, Science City of Muñoz, Nueva Ecija participated in by a sole bidder (JHAK CONSTRUCTION);
