CONTRACT AGREEMENT FORM

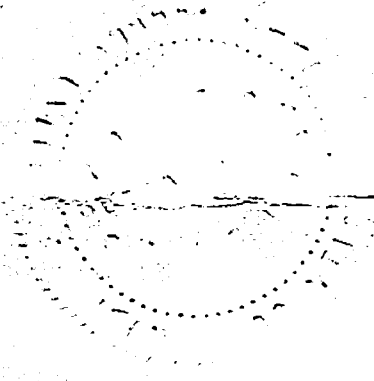


