**WHEREAS**, the aforementioned request was approved as detailed below:

**WHEREAS**, the Philippine Carabao Center (PCC), an attached agency of the Department of Agriculture, was created by virtue of Republic Act No. 7307;

**WHEREAS**, PCC is mandated to conserve, propagate and promote the Carabao as a source of milk, meat, draft power and hide to benefit the rural farmers;

**WHEREAS**, in order to attain the above objectives, the procurement of supplies, services and other materials are needed to sustain operations;

**WHEREAS**, in accordance with Sections 3 and 4, Article I of Republic Act No. 9184 and Sections 4.1, Rule I of its Implementing Rules and Regulations (IRR), public bidding is required in the procurement of infrastructure projects, goods and consulting services;

**WHEREAS**, the public bidding for the said project resulted to two (2) failed biddings as per BAC Resolution Nos. 2019-445 and 2019-503 and the BAC recommended the adoption of Negotiated Procurement (Section 53.1-Two Failed Biddings) pursuant to the Revised IRR of RA 9184;

**WHEREAS**, funds for the purpose is available;

**WHEREAS**, the Invitation to Bid (ITB) for the negotiated procurement was posted in the Philippine Carabao Center official website on 10 November 2019 and simultaneously posted in the following:

WHEREAS, in response to the Invitation to Bid, FIRST PHILIPPINE SCALES, INC. secured the documents relative to the project;




