CONTRACT AGREEMENT FORM

THIS AGREEMENT made on 12 September 2019 between the **PHILIPPINE CARABAO CENTER**, an agency of the Government of the Philippines with address at Science City of Muñoz, Nueva Ecija, represented by its Executive Director, **DR. such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.



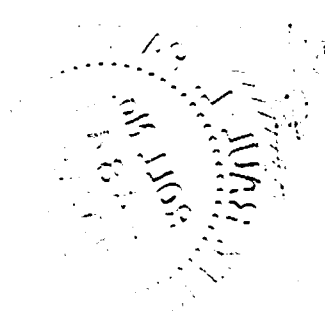
