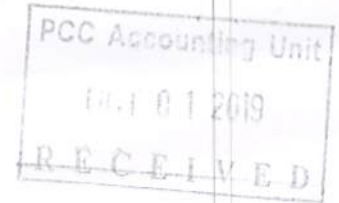

CONTRACT AGREEMENT FORM

THIS AGREEMENT made on 9 September 2019 between the **PHILIPPINE CARABAO CENTER**, an agency of the Government of the Philippines with address at Science City of Muñoz, Nueva Ecija, represented by its Executive Director, **DR. ARNEL N.
