CONTRACT AGREEMENT FORM

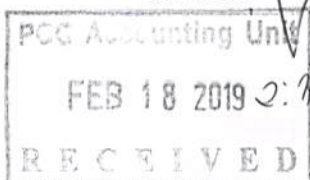




