

CONTRACT AGREEMENT





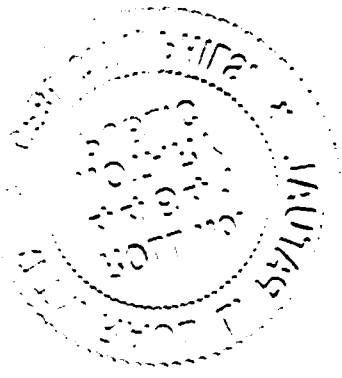
