CONTRACT AGREEMENT

THIS AGREEMENT made this 2nd day of December 2020 between **PHILIPPINE CARABAO CENTER** of the Philippines (hereinafter called "the Entity") of the one part and **ED RANCH** of Matungao, Masbate City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly (PCC-PCA) SUPPLY AND DELIVERY OF CROSSBRED BUFFALOES (68 HEADS) PCC-WVSU and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Million Seventy-Three Thousand Two Hundred Pesos (P 4,073,200.00)** (hereinafter called "the Contract Price").

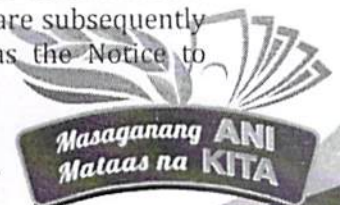
NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to




