



CONTRACT AGREEMENT

THIS AGREEMENT made this 20th day of November 2020 between **PHILIPPINE CARABAO CENTER** of the Philippines (hereinafter called "the Entity") of the one part and **ALL CERTIFIED EQUIPMENT TRADING CORPORATION** of 905 Philam Homes EDSA, 1104 Quezon City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly SUPPLY AND DELIVERY OF ONE (1) UNIT BRAND NEW DIESEL AC POWER GENSET 75KVA (SILENT TYPE) PCC-UPLB (REBID) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Two Hundred Ninety Thousand Pesos (P 1,290,000.00)** (hereinafter called "the Contract Price").
