

RECOMMENDING AWARD OF CONTRACT FOR THE EMERGENCY CONSTRUCTION OF DAIRY PROCESSING PLANT (PCC-LCSF) THRU BAYANIHAN 2 (RA NO. 11494)

WHEREAS, on 24 November 2020, Center Director ARIEL L. ABAQUITA, as Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP);

WHEREAS, included in the APP is the EMERGENCY CONSTRUCTION OF DAIRY PROCESSING PLANT (PCC-LCSF) to be undertaken through Emergency Procurement under Republic Act No. 11494 or the "Bayanihan to Recover as One Act" (Bayanihan 2) in view of the unabated spread of the COVID-19 virus ensuring economic disruption therefrom. Section 4(u) of Bayanihan 2 exempts specific procurement projects related to the COVID-19 response from the coverage of Republic Act No. 9184 (Government Procurement Reform Act) under the Bayanihan Fund;

WHEREAS, the emergency construction of the Dairy Processing Plant/Facility is in line with the establishment of the Province-wide Carabao-based Business Improvement Network (CBIN);

WHEREAS, this project aims to support the processing of milk from the established Carabao of the Provincewide Carabao-based Business Improvement Network (CBIN) propelling an inclusive, sustainable, and highly competitive local dairy industry particularly in the processing of milk to be supplied for the National Milk Feeding Program of the Department of Education (DepEd) and the Department of Social Welfare and Development (DSWD);

WHEREAS, considering all other factors of the procurement and with due consideration of the needs of the end-user, the adoption of Bayanihan 2 as the mode of procurement is advantageous to the PCC/government;

WHEREAS, the EMERGENCY CONSTRUCTION OF DAIRY PROCESSING PLANT (PCC-LCSF) THRU BAYANIHAN 2 (RA NO. 11494) has the following Approved Budget for the Contract (ABC) as follows:

WHEREAS, on 11 January 2021, the PCC-LCSF thru its Procurement Unit and the End-user initiated the procurement activity by sending/posting Request for Quotation (RFQs) to a supplier of known technical, legal and financial qualifications;

WHEREAS, ACCU-FIT BUILDER AND CONSTRUCTION SUPPLY has submitted their respective quotation/proposal for the requirement of PCC;

WHEREAS, MR. ARIEL L. ABAQUITA, Center Director of PCC-LCSF has issued a certification stating that the PCC-LCSF exerted all efforts to secure the most advantageous price to the government based on existing/prevailing market price (compliance to GPPB Resolution No. 18-2020 dated 16 September 2020);

WHEREAS, the Technical Working Group (TWG) determined that based on the financial proposal submitted by the sole supplier ACCU-FIT BUILDER AND CONSTRUCTION SUPPLY has submitted the single calculated quotation for

WHEREAS, upon review and evaluation of the compliance with the technical requirements of the procurement at hand, the TWG recommended to declare ACCU-FIT BUILDER AND CONSTRUCTION SUPPLY as the single calculated and responsive quotation;

WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A", and made an integral part hereof;

NOW, THEREFORE, WE, the Members of the BIDS AND AWARDS COMMITTEE after duly considering the justification of end-user hereby award the contract to ACCU-FIT BUILDER AND CONSTRUCTION SUPPLY for the EMERGENCY CONSTRUCTION OF DAIRY PROCESSING PLANT (PCC-LCSF) THRU BAYANIHAN 2 (RA NO. 11494) in the amount of One Million Two Hundred Eighty Thousand Four Hundred Fifty-Seven Pesos & 86/100 (P 1,280,457.86).

This resolution shall take effect immediately.
