

WHEREAS, the Philippine Carabao Center (PCC), an attached agency of the Department of Agriculture, was created by virtue of Republic Act No. 7307;

- 2) To recommend for approval by the OIC, Executive Director of the PHILIPPINE CARABAO CENTER the foregoing findings.




