

CONTRACT AGREEMENT

THIS AGREEMENT, made this SEP 13 2021 between **PHILIPPINE CARABAO CENTER** of Science City of Muñoz, Nueva Ecija (hereinafter called the "Entity") and **NGP CONSTRUCTION** of No. 01 Dona Rosa Adou St. Toril, Davao City (hereinafter called the "Contractor").
