CONTRACT AGREEMENT

THIS AGREEMENT made this 18 May 2022 between **PHILIPPINE CARABAO CENTER** of the Philippines (hereinafter called "the Entity") of the one part and **K SERVICIO TRADE INC.** of 111 12th Street Cubao, Quezon City (hereinafter called "the Supplier") of the other part;

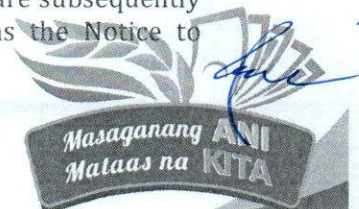


