

CONTRACT AGREEMENT

THIS AGREEMENT, made this APR 13 2021 between **PHILIPPINE CARABAO CENTER** with Office Address at National Headquarters and Gene Pool, Science City of Muñoz, Nueva Ecija represented herein by its OIC, Executive Director, **DR. RONNIE D. DOMINGO** (hereinafter called the "ENTITY")

and

G.R. ERCILLA CONSTRUCTION with office address at Kadena De Amor St., Villa Ramos Subd., Brgy. Abar 1st, San Jose City, Nueva Ecija represented herein by **MR. GEORGE R. ERCILLA** (hereinafter called the "CONTRACTOR").

WHEREAS, the Entity is desirous that the Contractor execute **REHABILITATION OF PROPERTY WAREHOUSE** hereinafter called "**the WORKS**") and the Entity has accepted the offer for **One Hundred Forty-Six Thousand Seven Hundred Eighty-Six Pesos & 92/100 (P 146,786.92)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. That the Entity is in need of the services of the Service Provider who shall perform works not performed by the regular personnel of the Entity;
2. That the Service Provider has signified his intention to which the Entity has accepted to provide service needed by the latter;
3. That the Service Provider hereby possess the skills, permit, licenses and resources required to perform the job as described herein;
4. Scope of Works:

(a) Includes all materials and labor for works as per attached Program of Works:

- i. Preparatory Works
- ii. Masonry Works
- iii. Steel Works



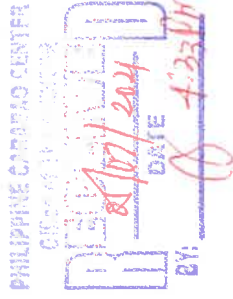
(b) Location: Philippine Carabao Center National Headquarters and Genepool, Science City of Muñoz, Nueva Ecija

- (d) BAC Resolution

- 6. The completion of the Works is required within thirty (30) calendar days after receipt of Notice to Proceed.
- 7. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 8. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- 9. The contractor shall issue invoice upon completion of Works.



RECOMMENDING AWARD OF CONTRACT FOR THE REHABILITATION OF PROPERTY WAREHOUSE

WHEREAS, on 8 January 2021, former OIC Executive Director CLARO N. MINGALA, as Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the agency upon favorable recommendation of the Bids and Awards Committee (BAC);

WHEREAS, included in the APP is the **REHABILITATION OF PROPERTY WAREHOUSE** to be undertaken through Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the GAA Fund;

WHEREAS, the **REHABILITATION OF PROPERTY WAREHOUSE** has the following Approved Budget for the Contract (ABC) as follows:

WHEREAS, on 16 March 2021, the BAC thru its Secretariat/Procurement Office, initiated the procurement activity by sending/posting Request for Quotation (RFQs) to PhilGEPS/various suppliers;

WHEREAS, only **G.R. ERCILLA CONSTRUCTION** has submitted their respective quotation/proposal before the deadline of submission;

WHEREAS, various suppliers were also requested to submit their respective quotations (see attached);

WHEREAS, the Technical Working Group (TWG) determined that based on the financial proposal submitted by the sole supplier, **G.R. ERCILLA CONSTRUCTION** has submitted the single calculated quotation for the project;

WHEREAS, as per Annex "H" CONSOLIDATED GUIDELINES FOR ALTERNATIVE METHODS OF PROCUREMENT, Small Value Procurement Procedure (ii) states that:

"The BAC shall prepare and send the RFQs to at least three (3) suppliers, contractors or consultants of known qualifications. This notwithstanding, those who respond through any of the required postings shall be allowed to participate. "Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof".

WHEREAS, upon review and evaluation of the compliance with the technical requirements of the procurement at hand, the TWG recommended to declare **G.R. ERCILLA CONSTRUCTION** as the single calculated and responsive quotation;

WHEREAS, the report containing the results of the TWG evaluation is attached hereto as **Annex "A"**, and made an integral part hereof;


