WHEREAS, the Entity is desirous that the Contractor execute **CONCRETING OF SLOPE SURFACE AT BASEMENT (REHABILITATION OF ERODED AREA)** hereinafter called "the WORKS") and the Entity has accepted the offer for **TWO HUNDRED THIRTY-FIVE THOUSAND NINETY-TWO PESOS & 48/100 (P 235,092.48)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. That the Entity is in need of the services of the Service Provider who shall perform works not performed by the regular personnel of the Entity;
2. That the Service Provider has signified his intention to which the Entity has accepted to provide service needed by the latter;
3. That the Service Provider hereby possess the skills, permit, licenses and resources required to perform the job as described herein;



**RECOMMENDING AWARD OF CONTRACT FOR THE CONCRETING OF SLOPE SURFACE AT BASEMENT (REHABILITATION OF ERODED AREA)**

**WHEREAS**, on 27 January 2021, OIC Executive Director CLARO N. MINGALA, as Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the PCC Hostel upon favorable recommendation of the Bids and Awards Committee (BAC);

**WHEREAS**, included in the APP is the **CONCRETING OF SLOPE SURFACE AT BASEMENT (REHABILITATION OF ERODED AREA)** to be undertaken through Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the Revolving Fund;

**WHEREAS**, the **CONCRETING OF SLOPE SURFACE AT BASEMENT (REHABILITATION OF ERODED AREA)** has the following Approved Budget for the Contract (ABC) as follows:

**WHEREAS**, only **G.R. ERCILLA CONSTRUCTION** has submitted their respective quotation/proposal before the deadline of submission;

**WHEREAS**, various suppliers were also requested to submit their respective quotations (see attached);

**WHEREAS**, the Technical Working Group (TWG) determined that based on the financial proposal submitted by the sole supplier, **G.R. ERCILLA CONSTRUCTION** has submitted the single calculated quotation for the project;

**WHEREAS**, as per Annex "H" CONSOLIDATED GUIDELINES FOR ALTERNATIVE METHODS OF PROCUREMENT, Small Value Procurement Procedure (ii) states that:

"The BAC shall prepare and send the RFQs to at least three (3) suppliers, contractors or consultants of known qualifications. This notwithstanding, those who respond through any of the required postings shall be allowed to participate. "Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof".

**WHEREAS**, upon review and evaluation of the compliance with the technical requirements of the procurement at hand, the TWG recommended to declare **G.R. ERCILLA CONSTRUCTION** as the single calculated and responsive quotation;
