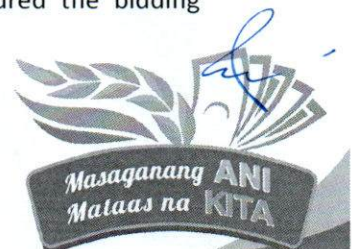
**WHEREAS**, funds for the purpose is available;

**WHEREAS**, RA 9184 provides that opening of eligibility documents shall be based on a non-discretionary pass/fail criteria;


**WHEREAS**, two (2) bids were submitted on 4 May 2022 and passed the preliminary examination of bid:




