

**BAC RESOLUTION NO. 2018-312**

**RECOMMENDING AWARD OF CONTRACT FOR THE MEALS (BASIC TRAINING ON BUSINESS CONCEPTS AND PRINCIPLES)**

**WHEREAS**, on 11 May 2018, Executive Director ARNEL N. DEL BARRIO, as Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the project "Strengthening San Agustin Crossbred Carabao-based Enterprise Development (CBED) Model (PCAARRD 5)" upon favorable recommendation of the Bids and Awards Committee (BAC).

**WHEREAS**, included in the APP is the **MEALS (BASIC TRAINING ON BUSINESS CONCEPTS AND PRINCIPLES)** to be undertaken through Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 DOST-PCAARRD Fund;

**WHEREAS**, the **MEALS (BASIC TRAINING ON BUSINESS CONCEPTS AND PRINCIPLES)** has the following Approved Budget for the Contract (ABC) as follows:

**WHEREAS**, upon careful review and evaluation of the Technical Working Group (TWG) on the legal and technical requirements submitted by the prospective suppliers, the TWG determined that **SAN AGUSTIN DAIRY COOPERATIVE** complied with the eligibility requirement as per attached document/s;

**WHEREAS**, the TWG determined that among the financial proposals submitted by the suppliers, **SAN AGUSTIN DAIRY COOPERATIVE** has submitted the lowest calculated quotation for the **MEALS (BASIC TRAINING ON BUSINESS CONCEPTS AND PRINCIPLES)** (July 30-August 8, 2018);

**WHEREAS**, upon review and evaluation of the compliance with the technical requirements of the procurement at hand, the TWG recommended to declare **SAN AGUSTIN DAIRY COOPERATIVE** as the lowest calculated and responsive quotation for the said services;

**WHEREAS**, the report containing the results of the TWG evaluation is attached hereto and made an integral part hereof;




