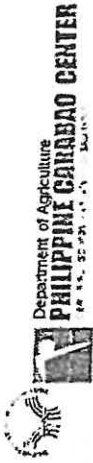



BAC RESOLUTION NO. 2018-655

RECOMMENDING AWARD OF CONTRACT FOR THE PRINTING WITH INSTALLATION OF DISPLAY MATERIALS, RENOVATION OF DISPLAY AREA AND MOBILIZATION AT PCC MAIN BUILDING (1 LOT)

WHEREAS, on 4 January 2018, Executive Director ARNEL N. DEL BARRIO, as Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the agency upon favorable recommendation of the Bids and Awards Committee (BAC);

WHEREAS, included in the APP is the **PRINTING WITH INSTALLATION OF DISPLAY MATERIALS, RENOVATION OF DISPLAY AREA AND MOBILIZATION AT PCC MAIN BUILDING (1 LOT)** to be undertaken through Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the GAA Fund;

WHEREAS, the **PRINTING WITH INSTALLATION OF DISPLAY MATERIALS, RENOVATION OF DISPLAY AREA AND MOBILIZATION AT PCC MAIN BUILDING (1 LOT)** has the following Approved Budget for the Contract (ABC) as follows:

WHEREAS, on 15 December 2018, the BAC thru its Secretariat/Procurement Office, initiated the procurement activity by sending/posting Request for Quotation (RFQs) to PhilGEPS/suppliers;

WHEREAS, only **SKYLITE ADVERTISING STUDIO CO, INC.** has submitted their respective quotation/proposal before the deadline of submission;

WHEREAS, various suppliers were also requested to submit their respective quotations (see attached);





WHEREAS, the Technical Working Group (TWG) determined that based on the financial proposal submitted by the sole supplier, **SKYLITE ADVERTISING STUDIO CO, INC.** has submitted the single calculated quotation for the project;

WHEREAS, as per Annex "H" CONSOLIDATED GUIDELINES FOR ALTERNATIVE METHODS OF PROCUREMENT, Small Value Procurement Procedure (ii) states that:

"The BAC shall prepare and send the RFQs to at least three (3) suppliers, contractors or consultants of known qualifications. This notwithstanding, those who respond through any of the required postings shall be allowed to participate. "Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof".

WHEREAS, upon review and evaluation of the compliance with the technical requirements of the procurement at hand, the TWG recommended to declare **SKYLITE ADVERTISING STUDIO CO, INC.** as the single calculated and responsive quotation;

WHEREAS, the report containing the results of the TWG evaluation is attached hereto as Annex "A", and made an integral part hereof;


NOW, THEREFORE, WE, the Members of the **BIDS AND AWARDS COMMITTEE** after duly considering the recommendations of the TWG, hereby resolve to recommend to the Head of the Procuring Entity for his considerations and approval of the contract to **SKYLITE ADVERTISING STUDIO CO, INC.** for the **PRINTING WITH INSTALLATION OF DISPLAY MATERIALS, RENOVATION OF DISPLAY AREA AND MOBILIZATION AT PCC MAIN BUILDING (1 LOT)** in the amount of **Six Hundred Sixty Thousand Pesos (P 660,000.00)**.


This resolution shall take effect immediately.


