**RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF STEEL MILK CANS AND PAILS**

**WHEREAS**, on 8 January 2020, Executive Director ARNEL N. DEL BARRIO, as Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) FY-2020 of the agency upon favorable recommendation of the Bids and Awards Committee (BAC);

**WHEREAS**, included in the APP is the **SUPPLY AND DELIVERY OF STEEL MILK CANS AND PAILS** to be undertaken through Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the GAA Fund;

**WHEREAS**, the **SUPPLY AND DELIVERY OF STEEL MILK CANS AND PAILS** has the following Approved Budget for the Contract (ABC) as follows:

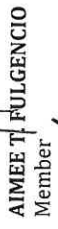
