

BAC RESOLUTION NO. 2020-134

RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF MEC-3 FLAVORINGS FOR GELATO

WHEREAS, on 16 January 2020, Executive Director ARNEL N. DEL BARRIO, as Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the Central Dairy Collection and Processing Facility (CDCPF) upon favorable recommendation of the Bids and Awards Committee (BAC);

WHEREAS, included in the APP is the **SUPPLY AND DELIVERY OF MEC-3 FLAVORINGS FOR GELATO** to be undertaken through Section 50 (Direct Contracting) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the Revolving Fund;

WHEREAS, the **SUPPLY AND DELIVERY OF MEC-3 FLAVORINGS FOR GELATO** was identified to be procured thru Direct Contracting whereby the supplier is simply asked to submit price quotation together with the conditions of sale and the said procurement of goods were critical components from a specific supplier and has a condition to hold a contractor/supplier to guarantee its performance;

WHEREAS, considering all other factors of procurement and with due consideration of the needs of the operating unit in the performance of their commitments and targets, the adoption of the alternative methods of procurement is advantageous to the government;

WHEREAS, the item requested was identified to be procured thru Direct Contracting based on the document/justification submitted by the end-user that:

- a) The CDCPF aims to introduce new flavors of gelato as part of its product improvement program. Pistachio and Choco-Hazelnut are two of the main premium flavors, along with other new flavors on the way that is expected to add great contribution to the Milka Krem sales and popularity;
- b) During the flavor development of gelato, the research and development team used MEC-3 flavorings and introduced them to different customers. The formulation using MEC-3 flavorings gained acceptance during the pilot production; and
- c) The MEC-3 flavorings is exclusively supplied by GRUPPO DOLCI INC. in the Philippines

WHEREAS, the **SUPPLY AND DELIVERY OF MEC-3 FLAVORINGS FOR GELATO** has the following Approved Budget for the Contract (ABC) as follows:
