BAC RESOLUTION NO. 2021-121

RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF SPECIFIC CHEMICALS AND LUBRICANTS FOR FARM MACHINERIES/EQUIPMENT

WHEREAS, on 8 January 2021, former OIC Executive Director CLARO N. MINGALA, as Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the agency upon favorable recommendation of the Bids and Awards Committee (BAC).

WHEREAS, included in the APP is the **SUPPLY AND DELIVERY OF SPECIFIC CHEMICALS AND LUBRICANTS FOR FARM MACHINERIES/EQUIPMENT** to be undertaken through Section 50 (Direct Contracting) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the GAA Fund;

WHEREAS, the **SUPPLY AND DELIVERY OF SPECIFIC CHEMICALS AND LUBRICANTS FOR FARM MACHINERIES/EQUIPMENT** was identified to be procured thru Direct Contracting whereby the supplier is simply asked to submit price quotation together with the conditions of sale and the said procurement of goods were critical components from a specific supplier and has a condition to hold a contractor/supplier to guarantee its performance;

WHEREAS, considering all other factors of procurement and with due consideration of the needs of the operating unit in the performance of their commitments and targets, the adoption of the alternative methods of procurement is advantageous to the government;

 - Corrected some problems encountered which were not addressed by using the previous commercial brands
 - Lessen the maintenance requirement of the units
- b) The products under "Certified" brand is manufactured and exclusively distributed by NCH Philippines, Inc, a subsidiary of NCH Corporation USA.


