

RECOMMENDING AWARD OF CONTRACT FOR THE MEALS AND SNACKS (SOCIAL PREPARATION TRAINING IN COORDINATION WITH NIZ AND LGU-GABALDON)

WHEREAS, on 8 January 2021, OIC, Executive Director CLARO N. MINGALA, as Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the agency upon favorable recommendation of the Bids and Awards Committee (BAC);

WHEREAS, included in the APP is the MEALS AND SNACKS (SOCIAL PREPARATION TRAINING IN COORDINATION WITH NIZ AND LGU-GABALDON) to be undertaken through Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the GAA Fund;
