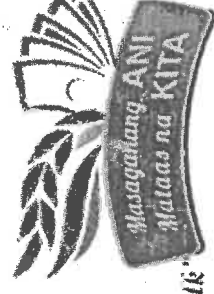

**RECOMMENDING AWARD OF CONTRACT FOR THE PRINTING AND DELIVERY OF TRAINING MANUALS (OFFSET PRINTING)**

**WHEREAS**, on 1 July 2021, OIC Executive Director RONNIE D. DOMINGO, as Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the agency upon favorable recommendation of the Bids and Awards Committee (BAC).

**WHEREAS**, included in the APP is the **PRINTING AND DELIVERY OF TRAINING MANUALS** to be undertaken through Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the GAA Fund;

**WHEREAS**, the **PRINTING AND DELIVERY OF TRAINING MANUALS** has the following Approved Budget for the Contract (ABC) as follows:

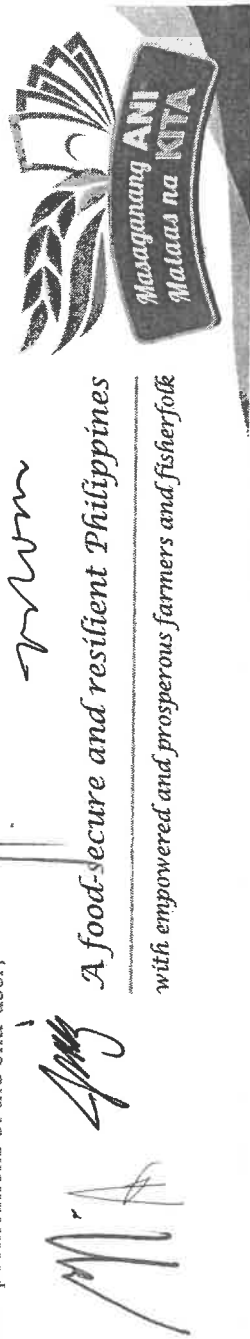

**WHEREAS**, upon review and evaluation of the compliance with the technical requirements of the procurement at hand, the TWG recommended to declare **G.A. PRINTING INC.** as the lowest calculated and responsive quotation for the said supplies/services;
