



RECOMMENDING AWARD OF CONTRACT FOR THE MEALS (ADVISORY BOARD AND VISIT OF SEC. WILLIAM DAR)

WHEREAS, on 1 July 2021, OIC Executive Director RONNIE D. DOMINGO, as Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the agency upon favorable recommendation of the Bids and Awards Committee (BAC).

WHEREAS, included in the APP is the **MEALS (ADVISORY BOARD AND VISIT OF SEC. WILLIAM DAR)** to be undertaken through Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the GAA Fund;


