**RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF RENZ BINDER SUPPLIES**

**WHEREAS**, on 30 September 2021, OIC Executive Director RONNIE D. DOMINGO, as Head of Procuring Entity (HOPE), approved the Indicative Annual Procurement Plan (APP) FY 2022 of the agency upon favorable recommendation of the Bids and Awards Committee (BAC);

**WHEREAS**, included in the APP is the **SUPPLY AND DELIVERY OF RENZ BINDER SUPPLIES** to be undertaken through Section 50 (Direct Contracting) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the GAA Fund;

**WHEREAS**, the **SUPPLY AND DELIVERY OF RENZ BINDER SUPPLIES** was identified to be procured thru Direct Contracting whereby the supplier is simply asked to submit price quotation together with the conditions of sale and the said procurement of goods were critical components from a specific supplier and has a condition to hold a contractor/supplier to guarantee its performance;

**WHEREAS**, considering all other factors of procurement and with due consideration of the needs of the operating unit in the performance of their commitments and targets, the adoption of the alternative methods of procurement is advantageous to the government;

**WHEREAS**, the item requested was identified to be procured thru Direct Contracting based on the document/justification submitted by the end-user that:

- a) PCC has existing Renz brand binding machine; and
- b) CITIBIND CORPORATION is the exclusive Renz Agent for office products in the Philippines.

**WHEREAS**, the **SUPPLY AND DELIVERY OF RENZ BINDER SUPPLIES** has the following Approved Budget for the Contract (ABC) as follows:

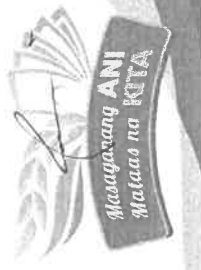

**WHEREAS**, the Technical Working Group (TWG) determined that based on the financial proposal submitted by the supplier, **CITIBIND CORPORATION** has submitted the single calculated quotation for the **SUPPLY AND DELIVERY OF RENZ BINDER SUPPLIES**;

**WHEREAS**, upon review and evaluation of the compliance with the technical requirements of the end-user/project, the TWG recommended to declare **CITIBIND CORPORATION** as the single calculated and responsive quotation;


