**RECOMMENDING AWARD OF CONTRACT FOR THE MEALS (PCC ANNUAL CHRISTMAS PARTY 2019)**

**WHEREAS**, on 16 April 2019, Executive Director ARNEL N. DEL BARRIO, as Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) FY-2019 of the agency upon favorable recommendation of the Bids and Awards Committee (BAC);

**WHEREAS**, included in the APP is the **MEALS (PCC ANNUAL CHRISTMAS PARTY 2019)** to be undertaken through Section 53.9 (Small Value Procurement) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the GAA Fund;

**WHEREAS**, the **MEALS (PCC ANNUAL CHRISTMAS PARTY 2019)** has the following Approved Budget for the Contract (ABC) as follows:

**WHEREAS**, upon careful review and evaluation of the Technical Working Group (TWG) on the legal technical requirements submitted by the prospective suppliers, the TWG determined that **PCC MULTI-PURPOSE COOPERATIVE** complied with the eligibility requirement as per attached document/s;

**WHEREAS**, the TWG determined that among the financial proposals submitted by the suppliers, **PCC MULTI-PURPOSE COOPERATIVE** has submitted the lowest calculated quotation for the **MEALS (PCC ANNUAL CHRISTMAS PARTY 2019) December 19, 2019**;

**WHEREAS**, upon review and evaluation of the compliance with the technical requirements of the procurement at hand, the TWG recommended to declare **PCC MULTI-PURPOSE COOPERATIVE** as the lowest calculated and responsive quotation for the said catering services;

**WHEREAS**, the report containing the results of the TWG evaluation is attached hereto and made an integral part hereof;
