required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- In consideration for the sum of One Million Two Hundred Ninety-Nine Thousand One Hundred Ninety Pesos (P 1,299,190.00) or such other sums as may be ascertained, REDSEA AGRO INDUSTRIAL CORPORATION agrees to supply, deliver and install the dairy processing equipment in accordance with his/her/its Bid.
- 4. The **PHILIPPINE CARABAO CENTER** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
