

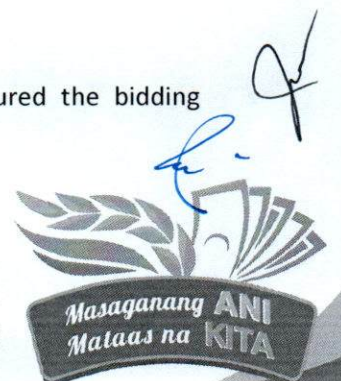
WHEREAS, funds for the purpose is available;


