





BAC RESOLUTION NO. 2023-582

RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF PASTEURIZED CARABAO'S MILK (93,360 PACKS) FOR DSWD REGION 4A BATANGAS

WHEREAS, the Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the agency/project upon favorable recommendation of the Bids and Awards Committee (BAC).

WHEREAS, included in the APP is the **SUPPLY AND DELIVERY OF PASTEURIZED CARABAO'S MILK (93,360 PACKS) FOR DSWD REGION 4a BATANGAS** to be undertaken through Section 53.12 (Negotiated Procurement-Community Participation) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the DSWD Trust Fund;

WHEREAS, on 22 June 2023, the BAC thru its Secretariat/Procurement Office, initiated the procurement activity by sending/posting Request for Quotation (RFQs) to THE ROSARIO LIVESTOCK AND AGRICULTURE FARMING COOPERATIVE;

WHEREAS, THE ROSARIO LIVESTOCK AND AGRICULTURE FARMING COOPERATIVE submitted their respective quotation/proposal;

WHEREAS, the Technical Working Group (TWG) determined that based on the financial proposal submitted by the supplier, **THE ROSARIO LIVESTOCK AND AGRICULTURE FARMING COOPERATIVE** has submitted the single calculated quotation for the **SUPPLY AND DELIVERY OF PASTEURIZED CARABAO'S MILK (538,080 PACKS) FOR DSWD REGION 4A QUEZON**;

WHEREAS, upon review and evaluation of the compliance with the technical requirements of the end-user/project, the TWG recommended to declare **THE ROSARIO LIVESTOCK AND AGRICULTURE FARMING COOPERATIVE** as the single calculated and responsive quotation;


