RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF PASTEURIZED CARABAO'S MILK (538,080 PACKS) FOR DSWD REGION 4A QUEZON

WHEREAS, the Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the agency/project upon favorable recommendation of the Bids and Awards Committee (BAC).

WHEREAS, included in the APP is the **SUPPLY AND DELIVERY OF PASTEURIZED CARABAO'S MILK (538,080 PACKS) FOR DSWD REGION 4a QUEZON** to be undertaken through Section 53.12 (Negotiated Procurement-Community Participation) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the DSWD Trust Fund;




