**RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF PASTEURIZED CARABAO'S MILK (51,600 PACKS) FOR DSWD BINIAN CITY, LAGUNA**

**WHEREAS**, the Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the agency/project upon favorable recommendation of the Bids and Awards Committee (BAC).

**WHEREAS**, included in the APP is the **SUPPLY AND DELIVERY OF PASTEURIZED CARABAO'S MILK (51,600 PACKS) FOR DSWD BINIAN CITY, LAGUNA** to be undertaken through Section 53.12 (Negotiated Procurement-Community Participation) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the DSWD Trust Fund;






