

**RECOMMENDING AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF STERILIZED CABARAO'S MILK (220,920PACKS X180- 200ML) FOR DSWD REGION 5 MASBATE**

**WHEREAS**, the Head of Procuring Entity (HOPE), approved the Annual Procurement Plan (APP) of the agency/project upon favorable recommendation of the Bids and Awards Committee (BAC).

**WHEREAS**, included in the APP is the **SUPPLY AND DELIVERY OF STERILIZED CABARAO'S MILK (220,920PACKS X180- 200ML) FOR DSWD REGION 5 MASBATE** to be undertaken through Section 53.12 (Community Participation) of the Revised Implementing Rules and Regulations of Republic Act No. 9184 under the DSWD Trust Fund;

**WHEREAS**, under RA 9184 Section 53.12 (Community Participation) wherein the interest of project sustainability or to achieve certain specific social objectives, it is desirable in selected projects, or its components, to call for participation of local communities through Community or Social Groups, or members thereof in the delivery of Goods and Simple Infrastructure Projects, subject to the Guidelines issued by the Government Procurement Policy Board (GPPB);

**WHEREAS**, considering all other factors of procurement and with due consideration of the needs of the operating unit in the performance of their commitments and targets, the adoption of the alternative methods of procurement is advantageous to the government;

**WHEREAS**, the item requested was identified to be procured through Community Participation based on the document/justification submitted by the end-user/National Milk Feeding Program Coordinator;

**WHEREAS**, the **SUPPLY AND DELIVERY OF STERILIZED CABARAO'S MILK (220,920PACKS X180- 200ML) FOR DSWD REGION 5 MASBATE** has the following Approved Budget for the Contract (ABC) as follows:


**WHEREAS**, the report containing the results of the TWG evaluation is attached hereto as Annex "A", and made an integral part hereof;

This resolution shall take effect immediately.






